Horizon Europe Roadshow on 24 October 2024

NICPs are in place for key thematic areas such as Agri-food, Engineering, Energy, ICT, Health, Digital Health, Social Science/Humanities and European Innovation Council. They will also be happy to advise any NI stakeholder on how to access the best support for any part of the Horizon Europe programme, for example MSCA, ERC.

Additional support is in place for North-South collaborations through Intertrade Ireland.

This means that organisations from Northern Ireland are eligible to participate in proposals on the same terms as organisations from EU Member States.

Northern Ireland and Horizon Europe

There have been 68 Horizon Europe awards to NI organisations between January 2021 and June 2024, totalling more than €25 million of funding drawdown to the region to-date.

Now that UK is an Associated Country, we are keen to boost NI participation and drawdown of EC funds to researchers across all sectors.

ONDEP - Ondas de Peniche

The Ondas de Peniche (ONDEP) project has been awarded €19 million to deploy a 2 MW wave energy array featuring four WaveRoller wave energy converters.



ONDEP will commence in October 2024 and last for five and a half years, encompassing the full spectrum of project activities — from design and manufacturing to testing, deployment, and operation. Set in the surfing hub of Peniche, Portugal, the pilot wave farm will be installed and connected to the grid and will continue generating electricity for an additional eight years after the project's official end.

ONDEP is led by Queen's University Belfast and the project includes 14 partners from across Europe, including leading companies and research institutions. These partners, coming from Belgium, Finland, France, Italy, Netherlands, Norway, Portugal, Spain, and the UK, bring together expertise covering the entire wave energy value chain. The Queen's team from the School of Natural and Built Environment will receive €1.7 million in funding from the project. The team led by Dr Pal Schmitt also includes Professor Mohammed Sonebei and Professor Su Taylor. Dr Pal Schmitt is associated to the Queen's University Marine Laboratory (QML) and the project will use QML's two wave tank facilities for small-scale modelling covering various aspects of Wave Energy Converter (WEC) technology. Professor Sonebi and Taylor will manage civil engineering aspects related to sustainable concrete foundations for WaveRoller.

In-Touch: a research project to improve quality of life for dementia patients

A €7.5 million research project involving a team of academics from Queen's University Belfast seeks to improve the care and quality of life for those with advanced dementia living in care homes.

People with advanced dementia who live and die in nursing homes experience varying quality of life and care. There is an urgent need to identify appropriate interventions that facilitate high-quality end-of-life care provision.

In-Touch is coordinated by University College Cork and will recruit 56 care homes across seven European countries to determine its effect on comfort, social engagement, and quality of life.

The results aim to create major change in the way that care for people with advanced dementia, in the palliative phase of their illness, is provided across Europe.

The Queen's team will be led by Professor Kevin Brazil, Professor of Palliative Care from the School of Nursing and Midwifery. Receiving funding of nearly €1 million, the Queen's team will lead the evaluation to determine the best conditions for applying



the intervention in different contexts across the continent. https://palliativeprojects.eu/in-touch/

UniMaaS: Unified Modeling and Automated Scheduling for Manufacturing as a Service

The recently awarded UniMaaS project is a €6.45M collaborative endeavour involving 17 partners across Europe and North America, including a team based at Queen's University Belfast. This project will develop a platform with a set of advanced technologies for offering flexible and decentralized manufacturing resources and supply chains as a Service to European SMEs and Industries. The platform will adopt advanced digital technologies such as cloud computing, digital twins and trustworthy AI, as key enablers towards fulfilling its objectives, and will provide easy access to customized manufacturing service chain and will support the entire life-cycle management of processes and products.

Bringing expertise in digital manufacturing, systems control and cyber-physical systems, this project represents almost €450k in funding for the Queen's University team which will be led by Dr Nikolaos Athanasopoulos, Senior Lecturer in the School of Electronics, Electrical Engineering and Computer Science, and will collaborate closely with the Advanced Manufacturing Innovation Centre (AMIC).

Laura Fitzmaurice, the NICP for Energy, attended the 43rd Cement and Concrete Science Conference at Riddell Hall in Belfast on 9-10th September. The conference provided an opportunity for scientists and engineers from both industry and academia to come together to discuss the latest developments in the field.

This conference provides an important platform for our young researchers to present their research and develop a network alongside established colleagues. As well as an opportunity to discuss the latest developments in the field of



cement and concrete science, this year's conference also presents an opportunity to celebrate the bicentenary of Joseph Aspdin's patent for Portland cement.

NICP's for Industry attend the European Innovation Council (EIC) Info Day, London

Lisa Braniff and Susan Bell, the NICP's for Industry, attended the European Information Council (EIC) Info

Day in London on 1st October 2024. EIC is Europe's flagship innovation programme to identify, develop and scale-up breakthrough technologies and game-changing innovations.

The information day introduced the main EIC calls including <u>EIC Pathfinder</u>, <u>EIC Transition</u> and the <u>EIC Accelerator</u>, which supports the development and scaling up of high-risk innovations by start-ups and SMEs.

Participants had the opportunity to hear from EIC representatives and industry experts, who provided valuable insights on navigating the application process. They also highlighted best practices and shared tips to improve project proposals.
